Committee Comment: **D We object on the planning grounds set out.**

1. We believe that the TPO was put in place to protect the amenity trees, on the whole site, there seems to be very little point in awarding TPO status if this can be waivered to suit the applicant. The CCTV could and should be repositioned, to avoid removing the oak trees which are the most biodiverse native tree and support a vast array of invertebrate, not to mention the wider benefits to small mammals and the amenity uplift to residents and visitors to the area.
